

Session focused on attracting private investment in the power sector. Issues of political will and tariff setting, project subsidy, skills shortage, and corruption were doscussed.


- New guide to 'Attracting Investors to African Public-Private Partnerships'



ICA Financing Water Meeting, Dakar, 27 – 28 Nov. 08

Meeting co-sponsored by ICA/USAID/PPIAF

High level attendance including 2 Ministers from Senegal and Madagascar (representing AMCOW), AU, RECs, River Basin Organisations, Private Sector, Public Sector, Water Utilities, ICA members and International Financial Institutions. Meeting held back-to-back with a workshop on credit rating for water utilities.



Keynote speakers from World Bank, PPIAF, EIB, AfDB, IFC, AFD, International Water Experts, Local Private Sector

Key Messages

- An emerging African private sector has delivered success stories
- Commitments from African countries to improve the investment climate
- Financial gap to meet water MDGs US\$4 billion
- New impetus required to find distinct solutions for fragile states (AICD findings)
- Urgent attention needed to finance multi-purpose dams for economic growth and to mitigate impacts of climate change

Outreach to the Arab Coordination Group

Members of the Arab Coordination Group are the Abu Dhabi Fund for Development, the Arab Bank for Economic Development in Africa (BADEA), the Arab Fund for Economic and Social Development (AFESD), the Islamic Development Bank, the Kuwait Fund for Arab Economic Development, the OPEC Fund for International Development OFID, Arab Gulf Programme for UN Development Organisations, and the Saudi Fund for Development



ICA Secretariat participated in as an observer for the first time

Strong interest in the activities of the ICA.

Following the recent Arab Economic Summit also held in Kuwait, members of the Coordination Group have decided to scale up assistance to Africa during this period of global economic crisis.

In the area of infrastructure, ICA seen as a useful platform for scaling up support and increasing their knowledge of the sector.

Missions to individual members of the Group will be at the appropriate time to identify concrete projects for possible collaboration between members of the Group and ICA members.



2007 Annual Report

- Needs remain high at around \$80bn (AICD)
- Africa received a minimum \$40 billion of external financial support to its infrastructure sector from all sources.
- ICA commitments reached **\$12.4 billion in 2007** this was an increase of 61% over the \$7.5 billion committed in 2006. ODA commitments in SSA increased by 59% to reach \$8.17 billion.
- Commitments by China, India and Arab partners estimated at \$4.5 billion, \$700 million and \$2.6 billion respectively

Challenges

- Africa's power crisis continues to demand urgent attention
- Action is required now to prevent what might become 'Africa's water crisis'
- A greater emphasis on regional solutions is needed
- The returns to reform and increasing the efficiency of existing infrastructure are high
- Significant additional spending will be required on urban infrastructure





PPP guide

- 'Attracting Investors to African Infrastructure Projects' will help the public sector in Africa to attract private sector investment through effective project advertising, management, and implementation.
- Guide will enhance the chances of developing effective public-private partnerships by overcoming major obstacles to project delivery by having the right information, on the right projects, for the right partners, at the right time.
- Assesses the relevant issues for selecting a project for public-private partnership, the actions for preparing projects for market, and the management process.
- Addresses hiring and managing expert advisers, explains how the public sector should interact with the private sector during the project selection and preparation phases to ensure that decisions during these phases are realistic
- And analyzes the issues of engagement with the private sector during the tender and after a contract has been signed.
